## **FAMPO RESOLUTION 13-27**

### **A RESOLUTION OF THE FREDERICKSBURG AREA METROPOLITAN PLANNING ORGANIZATION AMENDING THE FY12-FY15 TRANSPORTATION IMPROVEMENT PROGRAM (TIP) TO TRANSFER FUNDS FROM PROJECT UPC 88699 TO PROJECT UPC 93225 AND ALSO CONCURRING WITH THE TRANSFER OF FUTURE FUNDS FROM UPC NUMBERS 88699 AND 100448 TO UPC 93225.**

**WHEREAS**, as a result of FHWA providing guidance that the Fall Hill Ave and Mary Washington Blvd. widening project (UPC 88699) is ineligible to receive CMAQ funds; as a result, \$856,663 of FY13-17 CMAQ funds were traded for Interstate funding in the same amount, and

**WHEREAS**, due to lower than expected Right-of-Way acquisition costs on UPC 100448 (Gordon Rd Commuter Parking Lot Expansion), \$943,338 of FY 2016 CMAQ funds are available for use on another regional priority, and

**WHEREAS**, a TIP Amendment is required to transfer the funding from UPC 88699 falling in Fiscal Years 2013 to 2015, and


**WHEREAS**, VDOT is also seeking formal concurrence from FAMPO to transfer the future funds (Fiscal Years 2016 and 2017) from both UPC 88699 and UPC 100448, and

**WHEREAS**, it is recommended that these surplus CMAQ funds (\$1,800,001 in total) be transferred to UPC 93225 (Onville Rd. intersection improvement) to fully fund this project through construction.

**NOW THEREFORE BE IT RESOLVED BY THE FREDERICKSBURG AREA METROPOLITAN PLANNING ORGANIZATION THAT THE FY12-15 TRANSPORTATION IMPROVEMENT PROGRAM IS HEREBY AMENDED BY TRANSFERRING \$636,932 IN FY 13-15 CMAQ FUNDS FROM UPC 88699 TO UPC # 93225.**

NOW THEREFORE BE IT FURTHER RESOLVED BY THE FREDERICKSBURG AREA METROPOLITAN PLANNING ORGANIZATION THAT IT ENDORSES THE TRANSFER OF \$1,163,069 OF FY2016 AND 2017 CMAQ FUNDS TO FROM UPC NUMBERS 88699 AND 100448 TO UPC 93225.
