**Notice of Public Review & Comment Period for the
Draft Fiscal Years 2015 – 2018 Transportation Improvement Program (TIP)**

Fredericksburg, VA – May 22, 2014 - The Fredericksburg Area Metropolitan Planning Organization (FAMPO) has released for public review and comment the draft Fiscal Years 2015-2018 Transportation Improvement Program (TIP). The comment period will begin on May 22, 2014 and will end on June 20, 2014. The intent of the comment period is to solicit input and comments from the public.

FAMPO is responsible for conducting the federally required metropolitan planning process in the greater Fredericksburg Region. Federal regulations require an MPO to develop a TIP which contains a listing of projects in their region expected to receive Federal funding over a four-year period. Federal regulations require the inclusion of any project in the Fredericksburg Region on which federal funds will be expended to be included in the TIP.
