

#### **FAMPO RESOLUTION 20-25**

AMENDING THE FY2018-2021 TRANSPORTATION IMPROVEMENT PROGRAM (TIP) TO APPROVE THE RW PHASE FOR UPC 109516, ROUTE 711 - CROSSOVER MOVEMENT CONVERSION AND THE RW PHASE FOR UPC 110914, #SMART18 - I-95 EXIT 126, RTE 1 SB ONTO SOUTHPOINT PKWY

WHEREAS, the Fiscal Years (FY) 2018-2021 TIP was adopted by FAMPO on May 15, 2017; and

WHEREAS, VDOT has requested that FAMPO add \$421,416 (HSIP) and \$131,645 (AC-HSIP) for FY20 and \$131,645 (ACC-HSIP) for FY21 to fund the RW phase for UPC 109516; and

WHEREAS, VDOT has also requested that FAMPO add \$293,781 (NHPP) and \$465,677 (AC-NHPP) for FY20 and \$465,677 (ACC-NHPP) for FY21 to fund the RW phase for UPC 110914; and

WHEREAS, additional project and funding information for each UPC can be found in the supporting documentation with this resolution; and

**WHEREAS**, since this action for UPC 109516 is a TIP administrative modification, it can proceed without a conformity determination.

WHEREAS, UPC 110914 is considered regionally significant and was included as such in the FY18-21 TIP and 2045 LRTP that received a conformity finding from FHWA dated August 2018. This amendment only changes the project funding and would not significantly change how it was modeled in the analysis (i.e., project termini, number of lanes, analysis year, etc.). Since this project is already included in a conforming TIP and LRTP, a new conformity determination is not needed.

**NOW, THEREFORE, BE IT RESOLVED** that the Fredericksburg Area Metropolitan Planning Organization Policy Committee hereby amends the FY2018-2021 TIP to reflect the changes in funding for UPC 109516 and UPC 110914.
