**1. Call Policy Committee Meeting to Order – Chair Jason Graham**

Chair Graham called the meeting to order at 7:30pm.

**2. Pledge of Allegiance**

Chair Graham led the pledge of allegiance.

**3. Roll Call and Determination of Quorum – Ms. Becky Golden**

Ms. Golden conducted roll call and determined a quorum present.

**4. Approval of the February 27, 2023, Policy Committee Agenda (ACTION ITEM)**

Motion was made to amend the February 27, 2023 Policy Committee agenda and add two items: 12. Closed Session, and 13. Return to Open Meeting; and revise Adjourn / Next Policy Committee Meeting to be item 14.

Motion to approve the agenda as amended: Ms. Bohmke; Second: Mr. Kelly

Motion passed with unanimous consent.

**5. Public Involvement**

*Comments and questions from members of the public are welcome at this time. Staff will also read comments submitted by the public prior to the meeting.*

Dennis Eshman suggested an alternative road network to I-95 which could help alleviate congestion.

Joe Bonds, a resident of Celebrate Virginia, requested information on the alternatives to a new river crossing.

FAMPO staff read aloud an email received from Jane Leeds, a member of the disabled community. Ms. Leeds' comments included advocating for a light rail system in the Fredericksburg region and provided research as to why light rail would benefit the region.

**6. Consent Agenda**

Mr. Ollis noted the minutes contained an error which staff has corrected. He also noted that every February, the GWRC / FAMPO MOU must be brought to the attention of the Policy Committee and requested Policy members to review and notify GWRC / FAMPO if any modifications are necessary for consideration.

Chair Graham thanked Vice Chair Bohmke for Chairing the January Policy Committee meeting during his illness.

Motion to approve the consent agenda: Mr. Kelly; Second: Ms. Vanuch  
Motion passed with unanimous consent.

## 7. FAMPO Administrator Report – Mr. Ian Ollis

Mr. Ollis provided information on the Safe Streets and Roads for All (SS4A) grant, freight safety, and the FAMPO long-term vision. GWRC was awarded the SS4A grant which will provide FAMPO the opportunity to investigate safety in our region, find dangerous hot spots, and develop a plan to remedy those. The Federal Department of Transportation will provide a small local match to write the Safety Action Plan, which will be utilized by localities to apply to the SS4A grant to construct the improvements.

Mr. Ollis shared 2019-2022 freight safety statistics from the Free-Lance Star article, “Big crashes on the rise,” which showed an increase in crashes and 4-5 crash deaths per year. Mr. Ollis noted the importance of staying aware of this information to work on the problems.

Mr. Ollis noted a three-month timeline for understanding, discussing, and working towards funding congestion issues in the region. In January, the Policy Committee received a presentation from the Virginia Passenger Rail Authority; February’s agenda includes presentations by the Department of Rail and Public Transportation and the Potomac and Rappahannock Transportation Commission (OmniRide); and in March, the Policy Committee will participate in a congestion workshop led by Scudder Wagg from Jarrett Walker & Associates.

Additionally, Mr. Ollis noted three actions we can do to address accessibility issues: amend the Long-Range Transportation Plan to include accessibility considerations for those with mobility, vision, and hearing impairments, identify key safety interventions in the SS4A Safety Action Plan, and ask localities and state partners to indicate what accommodations are included in each funding application which we support and/or approve.

Lastly, Mr. Ollis discussed upcoming FAMPO funding and finances, including CMAQ and STBG allocations.

## 8. Action/Discussion Items

- a. Election of Policy Committee Second Vice Chair (ACTION ITEM)

Motion was made to nominate Lori Hayes to represent Spotsylvania County as the Second Vice Chair for the Policy Committee.

**b. Transit Options for the FAMPO Region to Address the Growing Congestion Crisis**

**1. Virginia Department of Rail and Public Transportation – Mr. Todd Horsley**

Mr. Horsley, Director of Northern Virginia Transit Programs, provided an overview of the Department of Rail and Public Transportation (DRPT), which primarily manages funding in the Commonwealth Mass Transit Fund and the Commonwealth Rail Fund, comprising 30.5% of the Transportation Trust Fund. Mr. Horsley also discussed state funding for future planned transit.

**2. OmniRide – Dr. Robert Schneider**

Dr. Schneider provided a mass transit perspective on congestion on I-95. He relayed a personal experience where after getting gas and parking his car at the gas station, he tried to walk to a restaurant but there was a fence built between the two buildings. He noted that this is common in development, where everything is built to be driven to, no matter how little distance there is between places. Dr. Schneider suggested next steps to keep in mind, especially during next month's congestion workshop: "How to Fund Transit Options and How to Integrate Those Options into the Road Network."

**c. Resolution 23-09 Adoption of the FAMPO Intraregional Multimodal East-West Mobility Study, Phase II Road and Bicycle / Pedestrian Report (ACTION ITEM)**

Mr. Ollis noted the amendments made to the East-West Mobility Study Phase II report, as per the comments received from the Policy Committee and the public. Members discussed adding a sentence on page 19 of the report which states "Any alignment shown in this report is representative for analysis only."

Motion was made to approve Resolution 23-09 with the additional sentence on page 19.

Motion: Ms. Bohmke; Second: Mr. Kelly  
Motion passed with unanimous consent.

**d. Senate Bill 1137 (Virginia, 2023) Creation of Fredericksburg Area Transportation Authority – Mr. Ian Ollis**

Mr. Ollis noted that the Senate Bill 1137 failed by one vote. Mr. Ollis recommended that when Policy Committee members discuss funding future projects, it would be smart to include a Regional Transportation Authority in that discussion.

**e. Adoption of Freight Summit Report and Presentation (ACTION ITEM) – Mr. Ian Ollis And Mr. Chris Lamm**

Mr. Chris Lamm provided an overview of the Freight Summit. Some next steps include integrating the findings into FAMPO's planning processes like the LRTP and CMP, developing a Regional Freight Plan, and continuing to maintain and expand freight stakeholder engagement.

Motion was made to adopt the Freight Summit report.

Motion passed with unanimous consent.

**f. CMAQ/STBG Draft Scores – Mr. John Ridout**

Chair Graham proposed a motion to move items F. and G. to a future meeting.

**g. CMP Performance Monitoring Program (PMP) Update – Ms. Becky Golden**

Moved to a future meeting.

**9. Correspondence**

Mr. Ollis noted the letter from Jane Leeds read aloud during the Public Comment section of the agenda, and the SS4A grant award.

**10. Staff and Agency Reports**

No staff or agency reports.

**11. Board Member and Chair Comments**

Mr. Kelly noted that funding future projects is going to take a regional approach; localities cannot fund projects by themselves.
