## FAMPO RESOLUTION 17-17

### A RESOLUTION OF THE FREDERICKSBURG AREA METROPOLITAN PLANNING ORGANIZATION AMENDING THE FY2015-2018 TRANSPORTATION IMPROVEMENT PROGRAM (TIP) TO ADD PE FUNDS FOR UPC 109479 - BIKE SHARE AND BICYCLE INFRASTRUCTURE IMPROVEMENTS STUDY


**WHEREAS**, as shown in the attachment to this Resolution, VDOT has requested that FAMPO amend its FY2015-2018 Transportation Improvement Program (TIP) to include new funding for the Bike Share and Bicycle Infrastructure Improvements Study in the FAMPO Region for \$40,000 in PE only; and

**WHEREAS**, this study will determine if bike share is feasible for the Fredericksburg area and what bicycle infrastructure improvements are needed for the City of Fredericksburg; and

**WHEREAS**, this study will satisfy requirements of the Bicycle and Pedestrian Plan, which is a component of the 2045 Long Range Transportation Plan (LRTP).

**NOW, THEREFORE, BE IT RESOLVED BY THE FREDERICKSBURG METROPOLITAN PLANNING ORGANIZATION THAT THE FY2015-2018 TRANSPORTATION IMPROVEMENT PROGRAM (TIP) IS HEREBY AMENDED TO INCLUDE \$40,000 OF NEW PE FUNDS FOR UPC 109479 - BIKE SHARE AND BICYCLE INFRASTRUCTURE IMPROVEMENTS STUDY.**
