## FAMPO RESOLUTION 19-11

### AMENDING THE FISCAL YEARS 2018-2021 TRANSPORTATION IMPROVEMENT PROGRAM TO ADD UPC 114620 AND UPC 110527

**WHEREAS**, the Fiscal Years (FY) 2018-2021 Transportation Improvement Program (TIP) was adopted by FAMPO on May 15, 2017; and

**WHEREAS**, the Virginia Department of Transportation (VDOT) has requested that FAMPO amend its TIP to add UPC 114620 and UPC 110527, which are associated with the 95 Express Lanes Fredericksburg Extension Project; and

**WHEREAS**, these TIP amendments will allow VDOT to provide oversight for the project and allow the right-of-way and construction processes to begin;

**NOW, THEREFORE, BE IT RESOLVED** that the Fredericksburg Area Metropolitan Planning Organization hereby amends the FY2018-2021 TIP to include UPC 114620 and UPC 110527, as shown in the attachments to this resolution.

Dear Mr. Agnello:

As you are aware, both the Department and the Fredericksburg Area Metropolitan Planning Organization (FAMPO) are committed to advancing the I-95 Fredericksburg Extension Project as a critical part of addressing transportation needs along the I-95 corridor and providing much needed congestion relief and new travel options to the Fredericksburg region. To that end, the Department requests that FAMPO amend its current Transportation Improvement Program (TIP) to add right of way and construction improvements (UPC 114620) and amend VDOT oversight costs (UPC 110527) associated with the I-95 Fredericksburg Extension Project.

Earlier this year, the Commonwealth and 95 Express Lanes, LLC (95 Express Lanes) announced our continued public private partnership to deliver this project. In addition, the Department and 95 Express Lanes have agreed on the material commercial terms necessary to finalize the Second Amended and Restated Comprehensive Agreement (Second ARCA) and the draft Second ARCA is under final review. It is anticipated that commercial close and execution of the Second ARCA will occur by March 1, 2019, with early works limited to those approved by the FHWA and the Department. Financial close is anticipated in summer 2019.

Project funding will include federal funds from the FASTLANE grant awarded to the Department in September 2016 as part of the Atlantic Gateway suite of projects, as well as private investment by 95 Express Lanes. The source of 95 Express Lanes private investment is anticipated to be comprised of equity and TIFIA credit assistance, for which an application has been submitted. 95 Express Lanes has demonstrated a successful history with financing tools such as TIFIA on other components of the 95 Express Lanes.

The existing and continuing partnership between the Department and 95 Express Lanes in delivering improvements along the I-95 corridor, coupled with 95 Express Lanes' commitment of private investment and demonstrated success with the TIFIA credit assistance program,

support that the funding sources noted above are anticipated to be reasonably available to support delivery of the I-95 Fredericksburg Extension Project.

We are eager to deliver the benefits of this project to the Fredericksburg region, users of the I-95 corridor, and the Commonwealth as quickly as possible and appreciate FAMPO's assistance.
